Enlargement

- authorisation to present an initiative report The enlargement debate will continue in 2001 and so it could be opportune to seek authorisation to present a specific initiative report on enlargement in connection with the area of freedom and judicial security.

- nominating of one or several "followers"

Following the 9 September 2000 decision of the Conference of Presidents, the concerned committees are asked to nominate one or several "followers" which are mandated to follow the works of the joint parliamentary committees according to their specific competences.

If, for instance, our committee nominates two "followers", these Members could naturally be designated corapporteurs of the initiative report in question.

- At the next joint Parliamentary committee EU-Bulgaria on 6-7
 November in Sofia, point 8 of the Agenda will be devoted to Justice and Home Affairs, including visa issues.
- On the celebration of the 50th anniversary of the creation of the High Commissioner of United Nations for Refugees, two events are proposed:
- 1) During the week of 4 December, sponsored by MEP José Maria Mendiluce Pereiro, UNHCR will stage an exhibition in the European Parliament premises in Brussels. The exhibition will display the historic and contemporary challenges of refugee protection and assistance, UNHCR's role, as well as the contribution of the European Union in the search to lasting solutions to the refugee problem. A detailed description of the exhibition is available in our secretariat.
- 2) Since our committee and the Committee on Foreign Affairs will be meeting in Brussels on 4 December, the representative of the Brussels seat of the UNHCR has asked whether we could organise a joint session, inviting members of the Development Committee (although that committee is not meeting those days its members are likely to be around).

If a joint session can be arranged, UNHCR said that a high level personality (Assistant High Commissioner?) could address the session and participate in an exchange with members on a broad theme (linked to the anniversary exhibition), i.e. the nature of contemporary displacement, Europe's role, UNHCR's work etc.

If this programme interests you and you agree with it, I propose that you allow me to write firstly to the Chairmen of the Foreign Affairs committee and secondly to the Cooperation and Development committee in order to seek their agreement and then, to begin the organisation related to it.

If however a joint session can not take place, we may wish to consider including this on the agenda of our committee, which means that we would need to focus on asylum in Europe.

You have received the documentation on this point. I recall that after a long process Coreper has finally reached an agreement on a text which according to our rapporteur could be taken on board. Mrs Paciotti was asked to seek further improvements to this text with a view to reaching agreement on first reading with the Council. I remind you that the Treaty foresees the creation of the European European Data control authority for 1 January 1999!

European citizens need this protection as soon as possible and for this reason we have to adopt a text as quickly as possible. For this reason Mrs Paciotti has tabled 63 amendments which take on board the Coreper text and has limited herself to 5 limited improvements. The five amendments in which Mrs PACIOTTI goes further than the Coreper text includes the following:

- amendment 3 (considérant 12) which inserts a reference to Art. 6 of the Union Treaty (fundamental rights) and to Art. 255 of the Community Treaty. This article will be the legal basis which institutions will have to follow when their activities in protecting personal data fall under the second and third pillar. The same "considerant" states that art. 286 will be conversely applicable in any case where activities falls totally or even partially within the first pillar (community rule).
- amendment 11 (art 3, premier para.) which repeats the principle that this regulation will be applicable in any case where activities falls totally or even partially within the first pillar (community rule).
- amendment 55 (on art 40 of the Commission proposal which corresponds to art. 42 of the Coreper text) which transfers the expenses in the Budget from the EP section to a separate section (8). This transfer has already been decided in the Budget 2001 (Deprez and Hernandez Mollar's opinion); and what must be avoided is the decision in this regulation regarding the title of the budget section (Mrs Paciotti has prepared an oral amendment to avoid this modification).
- amendment 56 (on art 43 of the Commission proposal which corresponds to art 46 of the Coreper text) which in letter (f) anticipates the need to

cooperate on one hand with national control authorities and on the other with third pillar control authorities.

- amendment 59 (on art. 46) which simply confirms the right of the future Authority to go to the Court according to Treaty rules (this was a specific Commission demand).

Mrs Paciotti has discussed these amendments with the French Presidency who have already contacted national delegations and a general consensus is now possible.

If our Committee adopts all the Paciotti amendments there is a real possibility that the procedure could end in the first reading.

For the vote I propose that we vote:

- en bloc all the Paciotti "compromise" amendments which correspond to the Coreper text
- en bloc the five Paciotti amendments which have been negotiated with the French Presidency but which are not yet in the Coreper text (but we know that there is major support by national delegations)
- vote on the legislative resolution

It will take only few minutes to do so instead of, an hour and a half following the traditional voting list which had previously been distributed.

Do you agree on this procedure, if yes we could start the vote. could you arrange this procedure with the other political groups (and in particular with the Rapporteur group) before the vote?
