The next point on the agenda is a Common Strategy of the European Union on Ukraine, adopted by the European Council in Helsinki on 11 December 1999.

The strategic partnership between the European Union and Ukraine, based on shared values and common interests, is a vital factor enhancing peace, stability and prosperity in Europe. The freedom, independence and stability of the Ukraine ranks among the greatest achievements in the new Europe ridding it of old dividing lines. Geography as well as size, the resources of its population as well as its location along the North-South and East-West axes gives Ukraine a unique position in Europe and makes it a determinant regional actor.

The common strategy lays down the following principal objectives:

- a) Support for the democratic and economic transition process in the Ukraine
- b) Ensuring stability and security and meeting common challenges on the European continent
- c) Support for strengthened cooperation between the European Union and Ukraine within the context of European Union enlargement

By adopting its Common Strategy, the EU has clearly demonstrated the importance it attaches to developing its relations with the Ukraine.

#### **Discussion**

In our meeting on 4 December Mrs Anna Terrón I Cusí prepared a draft opinion which has been translated into all languages. A deadline for amendments was set for 18 December 2000.

#### **Background**

The aim of this proposal for a directive (French initiative) is to approximate financial penalties on carriers who fail to meet their obligation to check that third country nationals are in possession of the necessary travel documents.

This proposal is part of a policy to combat illegal immigration at European level.

A first exchange of views took part on 22 November 2000. The rapporteur prepared a draft report due to be adopted today and a deadline for amendments was fixed for 8 January 2001.

However, due to substantial changes to the initial text which has been introduced by the Council, the EP is now being reconsulted; and consequently the adoption of Mr Kirkhope's draft report has had to be postponed.

#### Discussion

The representative of the Swedish Presidency will be asked to comment on the main changes introduced in the initial text presented last September by the French Presidency on which Mr Kirkhope's draft report was based.

This presentation will then be followed by an exchange of views.
